The UNIQA Group is one of the leading insurance groups in its core markets of Austria and Central and Eastern Europe (CEE). With approximately 40 companies in 18 countries, the UNIQA group serves about 15.5 million customers.

Our portfolio, currently consisting of more than 30 tech startups and one unicorn, has seen four exits since 2016 and has so far delivered a solid double-digit return.

Backed by a strong financial investor we are a small but dedicated entrepreneurial team with a clear financial return focused on a mission to provide smart growth capital. Our investment comes with the additional benefit of deep domain know-how in Financial Services, Insurance and Healthcare as well as a strong network in our core markets of Austria and central and Eastern Europe (CEE).
